

WAIVER AND RELEASES FROM LIABILITY AND INDEMNITY AGREEMENT

By joining the Traverski Club, Inc., the prospective member acknowledges that Traverski Club, Inc. is a not for profit corporation organized for the sole purpose of organizing and sponsoring social gatherings and recreational activities of a sporting nature for its membership, that many of these social gatherings and recreational activities organized and sponsored by Traverski Club, Inc. involve participation by its members and their guests in activities and sports recreation which involve risks of bodily injury and property damage and that Traverski Club, Inc. carries no insurance of any nature covering either itself or its members and their guests for any type of bodily injury or property damage that they may sustain while going to, participating in, or returning from any club function or activity. In consideration of being granted membership in Traverski Club, Inc. with the privileges and rights incident thereto, the undersigned for him/herself, his/her heirs, administrators, executors, assigns and next of kin forever release, relinquish, give up, forgo, waive and discharge Traverski Club, Inc., its agents, officers, assistants, employees and servants during the entire term of membership from any and all liability, claims demands, actions, courses of action, and debts whatsoever, which the undersigned may have, now has, or which may occur in his/her favor in the future, or which in the future or presently his/her heirs, executors, administrators, assigns and next of kin have or may hereinafter have against Traverski Club, Inc., its agents, officers, assistants, employees or servants, which arise out of injury or damage to his/her person or property, or resulting in his/her death whether such injury or damage be known or unknown, present or future, by virtue of or in any way arising out of or resulting from going to, participation in, or returning from any club function, activity, exhibition, or contest organized or sponsored by Traverski Club, Inc. or in which Traverski Club Inc., shall be in any way interested, and regardless of how such injury, claim, loss or damage may arise, and regardless of who is at fault or whose negligence caused such loss, damage or injury, or even if the loss is caused by the neglect or fault of Traverski Club, Inc., its agents, officers assistants, employees or servants while acting in such capacity. The undersigned further hereby assumes voluntarily all responsibility and risks for any injury or damages to his/her own person or property or for any injury resulting in his/her death while going to, participating in or returning from any Traverski Club, Inc. function or activity as against Traverski Club, Inc., its agents, officers, assistants, employees and servants and does hereby further to save and hold harmless, and indemnify each and all of the parties here-in-above referred to, free and clear of all liability, from and for loss, cost or damage, by reason of any injuries suffered by the undersigned to person or property or resulting in his/her death, by virtue of his/her going to, participating in or returning from any Traverski Club, Inc. function or activity even though such loss, injury or damage is caused by the neglect or fault of Traverski Club, Inc., its agents officers, assistants, employees or servants. The undersigned further agrees to save all of the said parties and each of them harmless from all liability, loss, cost or damage, including any court costs, attorney fees or any expenses whatsoever, by virtue of any injury or loss claimed by the undersigned or anyone for him/her or on his/her behalf, or by his/her personal representative, or next of kin, either in connection with any suit or otherwise against any of the persons or corporations or any of their agents, servants, officers, or employees, or other parties, here-in-after mentioned and herein intended to be released and indemnified. If any portion hereof shall be held valid, the balance shall notwithstanding, continue in full force and effect.
